CALL TO ORDER:

Chairman Craig Russell called the meeting to order at 10:05 a.m.

RECOGNITION OF THE NEWS MEDIA:

Senior Corporal Ricky Briggs, Board Administrator, confirmed notification of the news media in regard to this meeting.

MINUTES:

Craig Russell asked for a motion to approve the minutes from the last meeting held on August 12, 2009. Kevin Sanders so moved. The motion was seconded by Joey Page and carried unanimously.

HEARINGS:

ROY L. HOLMES (BG 09-300) Mr. Holmes testified. There was not a manager or supervisor from the company present with Mr. Holmes.

Kevin Sanders made a motion to approve his registration and assess a \$200 fine for making a material misstatement on his application.

Kevin Sanders made a motion to order the company to appear before the Board on October 14, 2009, for not being present with an employee that was scheduled to appear as required by Board rule. The motion was seconded Joey Page and carried unanimously.

JOSHUA D. NOBLES (BG 09-320) Mr. Nobles testified. Darin M. Jones, his supervisor, testified.

Jordon Brown made a motion to approve his registration and assess a \$200 fine for making a material misstatement on his application. The motion was seconded by Joey Page and carried unanimously.

CYNTHIA D. WILLIAMS (BG 09-330) Ms. Williams testified. Leo Hampton, Registered Manager, testified.

Kevin Sanders made a motion to approve her application and assess a \$200 fine for making a material misstatement on her application. The motion was seconded by Kendric Perry and carried unanimously.

ATLAS SECURITY SERVICE, INC. (BG 09-043) Mr. Barry Buffington testified. John Adams, Central Station Manager, testified.

Jordon Brown made a motion to find the company guilty of violating the state statute and assess a \$4,500 fine. The motion was seconded by Joey Page and carried unanimously.

APX ALARM SECURITY SOLUTIONS INC. (BG 09-046) The Board was represented by Assistant Attorney General Don Barnes. APX Alarm Security Solutions, Inc. was represented by Attorney Herb Rule.

Herb Rule requested that the Board delay the meeting. Jordon Brown made a motion to hear the case on September 9, 2009, as scheduled. The motion was seconded by Joey Page and carried unanimously.

Sr. Corporal Ricky Briggs, Board Administrator, testified. Nathan Wilcox, with APX Alarm Security Solutions, Inc. testified. Sylvia Smith Jackson testified. Mildred Crow testified. Davis Mills, Manager of Magnum Security, testified. Amy Hancock, Board Investigator, testified.

Nathan Wilcox, of APX Alarm Security Solutions, Inc. addressed the Board and advised them that Mrs. Sylvia Smith Jackson, a complainant, that the contract with the company was canceled.

Herb Rule requested that one of the fraud charges against APX Alarm Security Solutions, Inc. be dismissed and the Board not hear anymore evidence on this charge. Kendric Perry made a motion that the Board not dismiss the charge, and that the Board hear the evidence on this charge. The motion was seconded by Jordon Brown and carried unanimously.

Jordon Brown made a motion to rescind one of the counts against the company due to the company being advised of the charge after the 365 day time frame allowed by the law, however all of the remaining charges will remain against the company. This motion was seconded by Kevin Sanders and carried with three in favor of the motion and two opposed.

Kendric Perry made a motion to find the company guilty of the second complaint of misrepresentation and assess a \$500 fine against the company. This motion was seconded by Jordon Brown and carried unanimously.

Jordon Brown made a motion to find the company guilty of violating the seven day notification rule and to fine the company \$350. The motion was seconded by Joey Page and carried unanimously.

Kendric Perry made a motion to revoke the company's license. The motion failed for lack of a second.

Jordon Brown made a motion to fine the company \$1,000 per violation (40 counts), and revoke the manager registration of Larry Evers. The motion was seconded by Joey Page and carried with one opposed.

The total fine assessed against the company is \$40,850.
